WALT CRAWFORD is a Senior Analyst in the Development Division of The Research Libraries Group, Inc. He is the author of nine books on various aspects of library automation, including *MARC for Library Use*; *Patron Access: Issues for Online Catalogs*; *Technical Standards: An Introduction for Librarians*; and *Desktop Publishing for Librarians*. He is a frequent contributor to several publications in the library field and edits the *LITA Newsletter* and *Information Standards Quarterly*.

M. LESLIE EDMONDS is Youth Services Coordinator at the St. Loius Public Library and was previously Assistant Professor at the Graduate School of Library and Information Science at the University of Illinois at Urbana-Champaign. She received the first Carroll Preston Baber Award with Paula Moore from ALA to support her research of children's use of library catalogs. She is currently developing training for children on how to use and understand online catalogs.

KATHRYN LUTHER HENDERSON, Professor, Graduate School of Library and Information Science, University of Illinois at Urbana-Champaign, has been teaching courses in cataloging, classification, bibliographic organization and technical services for twenty-five years. Recently, with William T Henderson, she has developed a course on the preservation of library materials. Among her publications are *Conserving and Preserving Library Materials* (UIUC, GSLIS, 1981) and *Conserving and Preserving Materials in Nonbook Formats* (GSLIS, UIUC, 1991), both co-edited with William T Henderson.

WILLIAM T HENDERSON is Preservation Librarian and Associate Professor of Library Administration in the University of Illinois at Urbana-Champaign. For more than twenty-five years, he has worked on a system-wide basis with binding and preservation in a large university library. He has incorporated preservation considerations and requirements into the library's binding contracts and procedures, and has been instrumental in developing a local in-house mending and repair facility into a conservation facility. He is a member of the Library's Preservation Committee; has been consultant for other institutions and agencies on the development of preservation methods and programs; and, with Kathryn Luther Henderson, teaches an annual course on Preservation of Library Materials in the Graduate School of Library and Information Science. He is co-editor of two books with Kathryn Luther Henderson:

Conserving and Preserving Library Materials (GSLIS, UIUC, 1981) and *Conserving and Preserving Materials in Nonbook Formats* (GSLIS, UIUC, 1991).

RALPH E. JOHNSON is Assistant Professor in the Department of Computer Science at the University of Illinois at Urbana-Champaign. He received a Ph.D. in Computer Science from Cornell University. His major research interest is object-oriented programming, and he has applied it to a number of areas, including user interface design. He teaches courses in user interface design, object-oriented programming, and other areas of computer science.

W. DAVID PENNIMAN is Libraries and Information Systems Director at AT&T Bell Laboratories. Prior to joining Bell Laboratories in 1984, he served as Vice President for Planning and Research for Online Computer Library Center (OCLC) where he established the Research Department in 1978. He has worked as a research scientist at the International Institute for Applied Systems Analysis in Austria and the Battelle Memorial Institute in Columbus, Ohio, where he was also Associate Manager of the Information Systems Section responsible for the development of the BASIS online retrieval and data management system. He holds a B.S. in Engineering and a Ph.D. in Communication Theory from Ohio State University. His experience in the field of information systems research and development has included involvement in the areas of human factors, human-computer interaction, computer networks, and information systems evaluation.

JOHN J. REGAZZI is President and CEO of Engineering Information, Inc., a not-for-profit information services and publishing company founded in 1884. Previously, he was Vice President of the H. W. Wilson Company responsible for computer services and electronic publishing. He received a Ph.D. in Information Studies from Rutgers University.

RICHARD RUBIN is Assistant Professor at the School of Library Science at Kent State University. He received his Ph.D. in Library and Information Science from the University of Illinois at Urbana-Champaign, and his M.L.S. from Kent State University. He is author of the book, *Human Resource Management: Theory and Practice*, and was formerly Personnel Director of the Akron-Summit County Public Library.

ELLIOT R. SIEGEL is Assistant Director for Planning and Evaluation at the National Library of Medicine. He has been with the

Library since 1976, starting as research scientist in NLM's research and development division and currently director of the Office of Planning and Evaluation, where he is responsible for the Library's long-range planning, evaluation research, and outreach activities. He received a Ph.D. in Communication and an M.A. in psychology from Michigan State University.
