14 **RELIABILITY** The *PSI* is produced by *ISI*, leader in producing proven information retrieval and dissemination services.

15 **CROSS-REFERENCED SUBJECT ENTRIES** Thousands of cross-references have been provided by experienced information specialists to simplify searching and identify appropriate synonyms, spelling variants, etc.
