Instructions for authors: Manuscripts should be in two copies and typed in double space. The title, name, and affiliation of the author and an abstract of 75 to 100 words should precede the article. Bibliographic references are to be consecutively numbered throughout the manuscript and typed in double space on separate sheets at the end. The journal follows *A Manual of Style*, 12th ed., rev. (Chicago: University of Chicago Press, 1969) in matters of bibliographic style, and recent issues of this journal may be consulted as well.
