His articles have appeared in *College & Research Libraries*, *Journal of Academic Librarianship*, *Library Research*, *Drexel Library Quarterly*, *Collection Management*, *Serials Librarian*, *Journal of Library Administration*, and *Collection Building*.

THEODORE J. HOSTETLER is currently Library Director at Lipscomb Library, Randolph-Macon Woman's College, Lynchburg, Virginia. His degrees include a B.A. in History from Blufton College and an M.A. in Library Science from the University of Iowa. Mr. Hostetler formerly served as Head of Access Services at the University of California, Davis and Syracuse University.
