Illinois Data Bank Access and Use Policy

Purpose of this Policy

The document outlines the Illinois Data Bank's commitment to facilitating access and use of University of Illinois at Urbana-Champaign research data, describes the mechanisms the Illinois Data Bank implements to fulfill this commitment, and provides those accessing Datasets from the Illinois Data Bank guidance on determining usage rights associated with each Dataset.

Dissemination of Content

The goal of ensuring dissemination of Datasets published in the Illinois Data Bank is fundamental to the Illinois Data Bank's mission. In order to uphold the Illinois Data Bank's commitment to facilitating access and use of University of Illinois at Urbana-Champaign research data, the Illinois Data Bank disseminates its contents through as many means as possible including:

- Facilitating the indexing of Descriptive Metadata by search engines.
- Providing persistent URLs and assigning Digital Object Identifiers (DOIs) for reliable citing and discovery of published Datasets.
- Registering Descriptive Metadata with the DataCite Metadata Store
 (https://www.datacite.org/services/metadata-store.html) for discovery of the content by harvesters and individuals seeking public information about Datasets.

The Illinois Data Bank is committed to investigating and implementing new methods for further dissemination of its contents as warranted.

Access to Content

Datasets published in the Illinois Data Bank are discoverable and openly available to anyone with access to the World Wide Web. Data Files and Metadata Files are provided at least in the original format deposited. When appropriate, items in proprietary formats may be converted to formats that can be opened and read using freely available software. When Data Files and/or Metadata Files in a Dataset are made available in a converted format, Research Data Service staff will document the conversion in the Dataset's associated Descriptive Metadata and/or Metadata File(s).

Tracking Use of Content

The Illinois Data Bank uses Google Analytics, a web analytics service provided by Google, Inc. ("Google"), which collects information, including device information and IP addresses, using cookies or similar technologies. The information collected will be transmitted to, and stored by, Google on servers in the United States. Google will use this information to support the University in evaluating use of the Illinois Data Bank website, compiling reports on website activity for website operators, and providing other services relating to website activity and Internet usage. Google may also transfer this information to third parties where required to do so by law, or where such third parties process the information on Google's behalf.



Illinois Data Bank users who do not want their data collected by the Google Analytics may wish to block the service by installing the Google Analytics opt-out browser add-on

(https://tools.google.com/dlpage/gaoptout). This add-on instructs the Google Analytics JavaScript (ga.js, analytics.js, and dc.js) to prohibit sending information to Google Analytics. Please note that refusing the use of cookies or disallowing Javascript, either by selecting the appropriate settings on your browser or by installing various third-party add-ons or extensions, may impede the ability to use the full functionality of this website.

Users of the Illinois Data Bank consent to the collection and storing of data about the users by Google in the manner and for the purposes set out above.

Creators of Datasets deposited in the Illinois Data Bank to which copyright applies (see Illinois Data Bank Help section: Research Data Copyright and Licensing) retain copyright unless otherwise stated. If a Dataset is under copyright, a user may use the Dataset in accordance with the terms asserted by the copyright owner or to the extent, if any, permitted under the fair use doctrine.

Datasets in Illinois Data Bank may be in the public domain or under a license that explicitly allows specific uses of the content. The Illinois Data Bank requires that Depositors define a license for their Dataset at the time of submission, and licensing information is displayed in the Descriptive Metadata for each Dataset. Creative Commons (that is, in this case CCO or CC BY) licenses are currently recommended as these licenses are emerging as best for facilitating Dataset re-use (see Illinois Data Bank Help section: Research Data Copyright and Licensing for more information). However, given the complicated and evolving nature of Dataset licensing, Depositors may also define any license of their choosing by uploading a license.txt file (which describes the license they choose to apply) when uploading their Data Files and other Metadata Files. This file may include, but is not limited to, other Creative Commons licenses, The University of Illinois/NCSA Open Source License, or a non-standard license. The Illinois Data Bank is not responsible for the legality, enforceability, or accuracy of Depositor-supplied license.txt files and is not accountable for any terms found within the license.txt file.

If copyright terms for, or ownership of, the submission change, it is the responsibility of the Depositor to notify the Illinois Data Bank of these changes.

The Illinois Data Bank waives any and all rights the Illinois Data Bank might have with respect to Descriptive Metadata in the Illinois Data Bank. To the extent that the Illinois Data Bank's own contributions to selecting and arranging Descriptive Metadata may be protected by copyright, the Illinois Data Bank dedicates such contributions to the public domain pursuant to a CCO Public Domain Dedication.
